DETAILS OF EXAMINATION


Examination of the lease up to the present time has shown only small deposits of iron ore.

Some drilling and tranching has been carried out in the lower regions and more drilling is to be done in the futura.


Several trips were made out to the lease and much of the territory was covered, studying the formations and collecting samples for assaying.

Attached hereto are sketches of approximate locations of drill holes and trenchings.





TOWNSHIP No. 27 RANGE 9 WEST OF 5th MERIDIAN.




TOWNSHIP No. 28 RANGE 9 WEST OF 5th MERIDIAN.


TOWNSHIP No. 28 RANGE 10 WEST OF 5th MERIDIAN.


