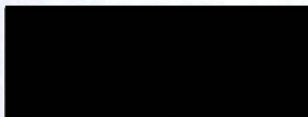
Feasibility of building a road needs to be analyzed so further study is required.

4.0 RESULTS

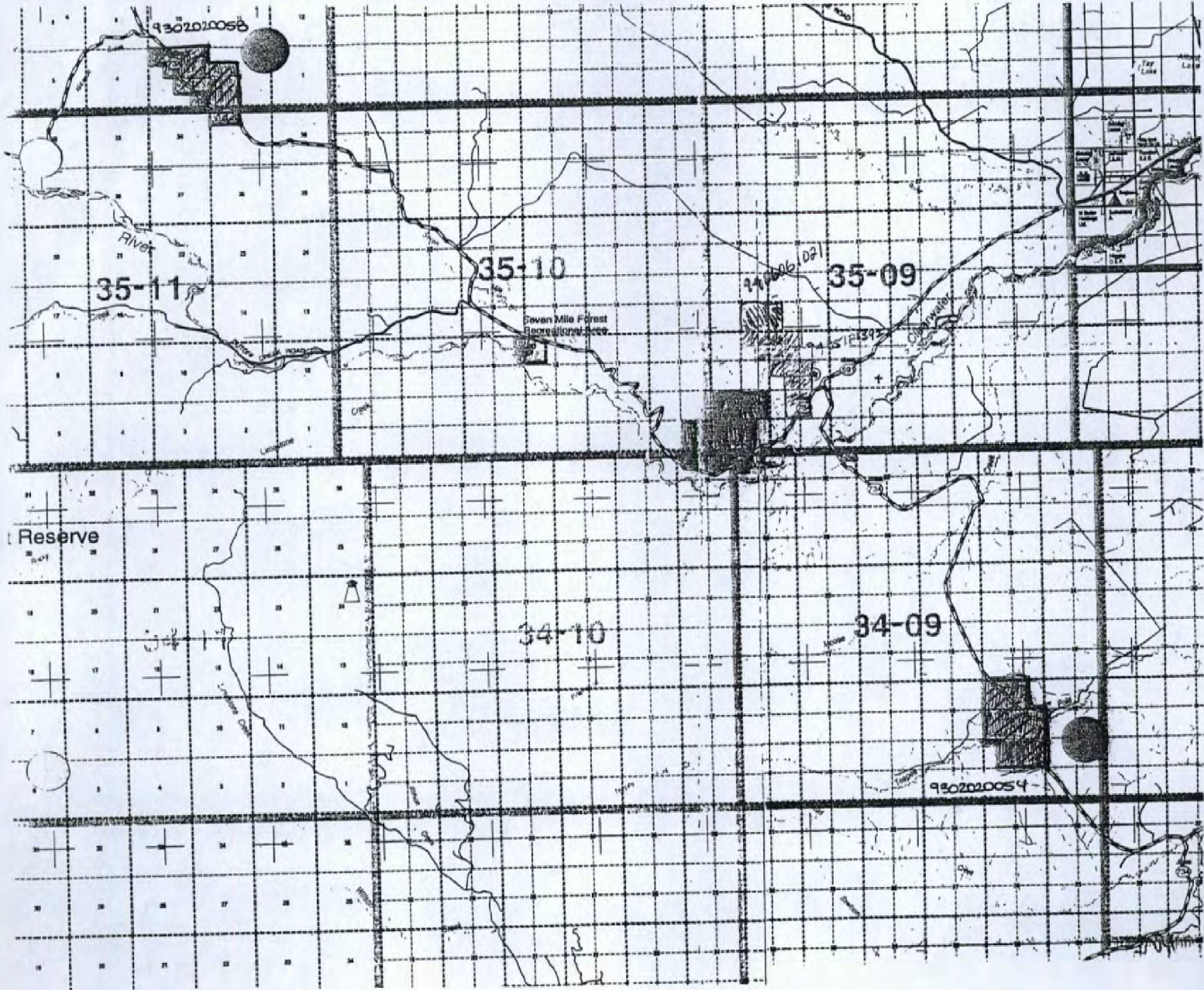
As of this date a decision on whether to proceed or quit has not been reached as costing is being compiled and studied.
